Journeys End is home to animals large and small that were abused, neglected, unwanted, at the risk of euthanasia or slaughter. Here, they get the care and love they need to heal and live out their lives in peace and comfort. The sole caretaker, Cathy, is a disabled Veterinary Technician who, despite her health challenges, has been caring for these animals for years with her own disability income.

Cathy has the time and expertise needed to help these unfortunate animals heal physically and emotionally and to live out their days in a happy, secure home, but her small disability income does not cover all the costs involved. She desperately wants to be able to continue this work, as it is her main reason for living. She offers phone consultation in holistic animal care, solving behavioral problems, natural hoof care, animal and human nutrition, detoxification, and dealing with environmental illness and Lyme disease, in exchange for donations to support the sanctuary. Because she has cared for many older animals at the end of their lives, she understands the pain involved with losing a beloved animal and is available for bereavement counseling.

Types of Animals Accepted: Exotic birds, predominantly CITES I and II endangered birds.

Limit of Animal Number: The limit of animals is restricted by the space that is available at any given time.

Two to four may not be a problem. It becomes a problem when people have large numbers of birds.

Rates: Each bird must be tested to our specific standards before we approve taking the bird, as this facility is very serious about insuring the continuing health of their existing flock. The tests (today) cost anywhere from \$250-400 per bird depending on the type of bird, tests needed and part of the country you live in (prices vary regionally we have discovered).

The Oasis Sanctuary realized a primary dream by acquiring and moving to a 71-acre parcel of land in the small community of Cascabel, located near the town of Benson in Southeastern Arizona. The temperate climate allows the healthy and able-bodied birds in our flock to be outdoors year round. The land contains a 21-acre non-productive pecan orchard. The deciduous trees provide a canopy of shade during the summer months and allow sunlight in winter. Birds with special needs and those that require more human interaction are kept indoors in our 1,300 square foot bird building. The Oasis Sanctuary was incorporated in the State of Arizona on May 22, 1997. We are a 501(c)(3) charitable organization. Our Federal EIN number is 86-0885646. We are also registered with the Secretary of State in Arizona as a recognized charity.

We *request* that the birds are sponsored annually. We do not accept birds because their caregivers have money. Nor do we turn away birds that should be here because their caregivers cannot afford to pay for their ongoing care. Sponsorship covers the annual base care of a bird and varies species by species. Example: a budgie costs about \$5 a month for us to care for while a large Macaw is about \$60 per month. We cannot look into someone's pocketbook or bank account. We only ask that people remain responsible and do the best they can...and if they can help birds who cannot be cared for by their former homes, that is most gratefully appreciated. We ask folks to keep in mind that those birds need care too. Every penny we generate goes into bird care and projects which enhance the lives of these birds. The Oasis Sanctuary is a Rescue and Retirement facility for exotic birds, predominantly CITES I and II endangered birds. We offer birds a stable and loving home for the duration of their natural lives. We do not sell or breed birds. Nor do we offer birds for adoption. The Oasis Sanctuary is proud to be the first exotic bird sanctuary to have dual accreditation from the American Sanctuary Association (ASA) and The Association of Sanctuaries (TAOS). Many of The Oasis birds come from other rehabilitation and/or adoption programs where qualified personnel have determined that it is not in the bird's best interests to be placed in private homes. Some of our birds have "special needs" or are physically handicapped or challenged, requiring unique living or feeding situations. Others have been bounced from home to home, often being physically and/or emotionally abused and have simply become too fearful of people to be companions to people. A number of The Oasis birds are retired breeders or other birds originally imported for reproduction purposes, and due to age, infirmity or temperament they would often be facing euthanasia. Because many of our birds are not interested in or are incapable of human interaction, they are housed with the same or similar, compatible species in non-breeding pairs or small flocks in large flight cages. The Oasis Sanctuary is also home to a small number of perfectly "normal" healthy and content birds, whose owners brought them here when life changes precluded them from continuing to care for their beloved companions. We accept birds whose owners have passed away or gone to nursing homes when the birds are willed to The Oasis or when family members make the request. These owners recognize that the stability of perpetual care at our facility, with companionship of both people and other birds, is preferable to the possibility of being bounced from home to home over the long lifetime of the bird.

TARA (a 501 (c) 3 nonprofit corporation) provides public education on the care and behavior of exotic birds, and takes in abused, unwanted, handicapped, and elderly parrots from all parts of the Southwest. We place these birds in safe, loving environments with knowledgeable caregivers.

Experienced bird lovers founded TARA in 1998 in response to the increasing number of unwanted birds and the needs of bird owners for good, up-to-date information on parrot care and behavior. One of TARA's main goals is to increase individuals' knowledge of what to expect from parrots and how to care for them properly. Parrots' high level of intelligence, their long lifespan, and their innate wild nature make their needs greater than most people can meet.

TARA does not "warehouse" rescued birds in a single facility. Instead, we provide them with more intimate surroundings and consistent caregivers; the care provided is determined by the individual bird's needs. Volunteers in their homes foster some birds, while others are housed in home aviaries with birds of their own species. TARA attempts to socialize rescued birds with other parrots as well as with humans, and we often pair up "bird buddies" of the same sex.

The Hermitage Cat Shelter is a nonprofit organization, supported entirely by private and corporate donations and it exists solely for the shelter, protection and care of homeless cats. It is Tucson's first no-kill, no-cage facility (except for quarantine). The Hermitage is a textbook example of how a fairly old private residence (built in 1948) can be converted to house over 300 cats and kittens in clean, yet homey conditions. Our facility comprises approximately 4,000 square feet under roof, with an additional 4,000 square feet of entirely fenced-in outdoor runs. Every one of our free-roaming felines has access to fresh air and sunlight without being in any danger from predators, vehicles, nasty people or other vagaries of civilization.

The Hermitage is moving in a new direction and is poised for great things. The shelter has positioned itself for increased adoptions and that means saving more cats in shelters who would face certain deaths. Last year in Pima County 18,000 dogs and cats were euthanized, and every year an estimated additional 1,000 animals are expected to be added to these numbers. The Hermitage is proud to say we are now a part of the solution. Through grant money, The Hermitage has made a commitment to spay/neuter both dogs and cats. The shelter is also rescuing cats from Pima County Animal Care Center and is working with animal rescue groups.

The Hermitage is and will continue to be a sanctuary for those cats who are not adopted. Our cats are currently getting the best medical available.

This free service began in 1979 as easy phone-in help for people with pet problems. In addition to these services, more than 1,500 cats have found shelter at Animal Helpline since 1979. Thirty dogs have also lived on location at Animal Helpline over the years. The grounds at the facility are open daily for visits, picnics and tours.

Expansion and completion of the shelter are ongoing, but are possible only through continuing tax-deductible donations by Helpline's friends. The shelter is run entirely by Judith Lindley and her family, which keeps the operating costs at a minimum.

The Peninsula Humane Society & SPCA (PHS/SPCA), a private nonprofit guided by the humane ethic, builds healthy relationships between people and animals. As an ethical choice, we accept all animals in need of care and often provide a second chance to the neediest animals: those who would otherwise be turned away at so-called "no kill" agencies that accept only highly adoptable animals. We also serve as our county's provider of animal rescue and control services and, as such, have no control over the number of incoming animals. Our record is outstanding. Since 2003, 100% of healthy, adoptable dogs and cats have been adopted. Our definition of "healthy" is based on the state's definition: dogs and cats without medical or behavioral issues and that are fully weaned and social. It excludes obviously unhealthy animals (those with injuries and illnesses or those behaviorally scarred from past treatment and mistreatment) as well as unweaned kittens and feral cats. Still, donations to our Hope Program allow us to make well, then place into new homes, approx. 170 animals every month. In February 2008, the Society celebrated accreditation by the American Animal Hospital Association (AAHA) following a comprehensive review of the shelter's veterinary program. Community education and outreach, partnerships, and a dedicated volunteer group greatly extend our mission and work.

The Peninsula Humane Society & SPCA's Hope Program helps the neediest animals and gives them a second chance at life. As an open-door shelter, PHS/SPCA accepts all animals regardless of their age, size, temperament and behavior. Some animals arrive perfectly healthy and need nothing more than a new loving home, but many others need extra medical care, behavior training, or TLC before they can be placed into a new forever home. For some of them, PHS/SPCA is their only chance. Hope saves an average of 170-175 animals every month. Thanks to generous support, this number keeps growing! North County Humane Society (NCHS) has established Friend for Life, the first program in San Luis Obispo County designed to protect animal companions who survive their owners. The Friend for Life program is designed to find loving homes for all surviving animal companions enrolled in the program, including cats, dogs, other small mammals, birds, horses and reptiles. If a permanent adoptive home cannot be found, NCHS will itself become a loving home or will find a protective sanctuary for the surviving animal. "Friend for Life is meant to give pet owners peace of mind," according to NCHS Past President Charlotte Alexander. By participating in Friend for Life, you know that your cherished animal companions will be taken care of should you die or become incapacitated unexpectedly. To participate in the program, a pet owner must be a member of the North County Humane Society. To enroll animal companions in the program, members make provisions through their will or other estate documents for NCHS to adopt surviving animals, and they are asked to make a planned gift, such as a bequest, to NCHS.

It is a gift of love to do such a simple thing for the animals that give you so much in return.

Every dog or cat is spayed or neutered prior to adoption. Pets In Need (PIN) is a private no-kill adoption shelter. This means that Pets In Need's humane work is made possible by donations. PIN has no city or county contracts and receives no local, state or federal tax money. Last year, 89% of PIN funding was donations from individuals and organizations that care. The ARF Guardian Program is a free service for ARF's adopters and supporters who specify in their will or trust document that their companion animals are to be entrusted to ARF at the time of the supporter's death. We are not a membership organization. We define membership as anyone who makes an annual contribution.

This program is our way of being there for our donors' furry friend when the donor is no longer able to be there. This service is for dogs and cats. There is a limit of two (2) pets per person, the animals must meet ARF's Health and Adoption standards, and the person must have been an annual donor. To ensure that your furry friend will be well cared for and safe if you should predecease your beloved friend, we recommend that the guardian prepare written instructions including their pet's likes and dislikes and the name of their furry friend's regular veterinarian. For your convenience, please see our web page for pet information forms. The information should be updated every six months and kept at home in a safe place.

The caregiver should also make arrangements with a trusted friend or relative to transport the companion animal to ARF when the time comes. The pet will be evaluated by our veterinarian and will be given any special care needed. Then we will begin looking for another loving home for the beloved pet. At ARF, no animal suitable for re-homing is ever put to death...no matter how long it takes. We are a completely privately

funded no-kill animal shelter. While our Guardian Program is free for donors we find that very often our supporters want to make a lasting legacy to help their pet or to help other pets. We are always grateful when one of our contributors wants to make a lasting gift for the animals.

Enroll Pets in the ARF Guardian Program, it's easy!

Step 1: Specify in will or trust documents that the guardian's pet is to be entrusted to ARF at the time of death: "At the time of my death, I give my pet(s) to the Guardian Program for placement in a loving home."

Step 2: Designate a friend, relative or the estate executor to act as interim caretaker and to bring the companion animal to ARF's caring staff.

Step 3: Complete the Guardian Program Pet Biography, providing information about the pet's food preferences, likes and dislikes, habits and special needs.

Step 4: Send a copy of the completed Pet Biography form to ARF and keep a copy with the guardian's will. ARF recommends updating the form every six months.

Step 5: Make annual donations to ARF. Any gift, large or small, will be used to save animals' lives.

Fee for Future Lifetime Care: \$5000 per cat regardless of age. Provisions may be included in wills or payment arranged. No cash outlay is necessary to begin the program but proof of your will or trust provision stating that Friends of Cats, Inc. has been named as provider for your cat's future care is necessary. These fees reflect the minimum amount required for the care of your cat(s). Cats live out their normal lives in comfort, care and lots of love. No cats are euthanized except for those suffering or diagnosed as "terminally ill" and then only when the shelter veterinarian has recommended euthanasia. Any funds over and above the fee enable us to provide a home and care for less fortunate cats.

Lifetime care provides:

1. Heated/air conditioned clean facilities
2. Seven-day-a-week medical supervision
3. Twenty-four-hour-a-day supervision
4. Regular grooming
5. Vaccinations and medications as required

Additional information can be obtained by writing or calling Friends of Cats. Friends of Cats is a private nonprofit organization located in El Cajon, California. We are dedicated to providing shelter and medical care to abandoned cats and those whose owners are unable to care for them. Once their health is assured, we try to find good homes for them. WE DO NOT PUT CATS TO SLEEP, except as a matter of compassion if they are fatally ill. Although the number of residents fluctuates, we usually have around 300 cats at the Shelter. We have recently expanded our facility for FELV/FIV cats, added a porch to our Shy Cat Trailer and updated our Cozy Cottage and our Kitten Cottage. We have made much progress, but we are still in great need of help in updating the Shelter and providing the best care for our feline friends. Friends of Cats began in 1927 when several San Diego men and women pooled their resources to form the Animal Rescue League and purchased all of the animals from the pound in order to place them in good homes. PET PRIDE is a California nonprofit organization, which was incorporated January 6, 1965. It is a humane, educational institution, which is trying to systematically deal with the problems faced by homeless, stray, abused, unwanted and neglected cats. It is the largest, oldest and most well-known charitable organization in the United States that deals solely with the cat. Its aims are to confront the problems of the feline and, through education, enable the cat to live a richer, fuller and happier life. In order that the public may see a proper cat environment at work and in order to help as many homeless cats as possible, we established a PET PRIDE Shelter in 1970 in Los Angeles which we call PET PRIDE's "Home for Cats." It is quite different from any other existing shelters for two very important reasons. Our resident cats live cage-free except for new admitters awaiting neutering or cats receiving medical treatment. We do NOT euthanize any of our cats for any reason except terminal, suffering illness. Our shelter consists of two regular houses, which are joined together by a large glassed patio. Other separate buildings include our admissions/office area, our clinic and our kitten "condo" that are to the rear. Each of our houses has large metal mesh doors, which separate the rooms and each room is designed to project a living room-type surrounding. Each house also contains a large fully screened and "escape proof" patio with many wooden shelves for climbing, sunning and playing. The access to both houses is from the rear, which itself is fully fenced to prevent escape. At any one time, we house and care for about 300 cats. We screen adopting parents to be certain they will provide devoted, indoor homes. We are limited in our number due to space requirements and, of course, funding. Cats who are new admits are checked for FIV and receive a medical examination. They receive their 4 in 1 shot and Leukemia shots and are weighed and their teeth checked. In the following days they are neutered or spayed if unaltered. They are then placed in our kitty house where they can become accustomed to living with other cats and where we closely monitor their eating and behavior patterns. The "cat" house is cageless and fully

furnished for the cats' comfort, and it is kept spotlessly clean. Food, fresh water and clean litter are always available. Low ash dry food is plentiful in supply and the cats are fed their "wet" meals twice daily that consist of nutritionally balanced beef by-products, specifically formulated for cats. There are toys to play with, sofas, chairs, cat climbing trees, pillows and beds to lay on, patios to visit and much human companionship, petting and loving. They are quite at home and ready and willing to greet our many shelter visitors. They are constantly watched for any signs of medical problems and any ill cat is immediately taken to our clinic. Routine problems are handled in-house and supervised by our overseeing vet; complex cases are treated at our veterinarian's hospital. We provide all of our "residents" with regularly scheduled booster vaccines and even regular dental care! Our cats are flea free, ear mite free and very healthy indeed. You won't see any sniffles or runny eyes in our midst and all of our cats receive devoted care from all of our staff and many volunteers.

The horses are supplemented twice daily on Elk Grove Mill Senior feed, dewormed regularly, given shots annually, and have their feet trimmed as needed. This annual budget will support daily hands-on care by our trained staff, volunteers and certified veterinary technician; a nutritious, well-balanced diet; indoor and outdoor psychologically enriched environments; and medical care by experienced avian veterinarians. The above information is only intended to serve as a guide. We will be pleased to discuss your individual bird's needs with you concerning your wishes for its long-term care, whether in sanctuary, foster care or adoption placement. The Gabriel Foundation has been in operation since 1996 and is a 501(c)(3) aviculture and veterinary-affiliated parrot welfare organization licensed by the state of Colorado, promoting educational outreach, conservation, rescue, rehabilitation, adoption, and sanctuary pertaining to the needs of parrots everywhere. The Gabriel Foundation maintains a sanctuary for parrots until they can be adopted, or in the event they are unable to be adopted. The number of residents at The Gabriel Foundation aviaries fluctuates between 150 to 200 birds. Our main aviary is an 8,500-square-foot building complete with separate bird species' rooms, play areas, and outdoor flights. The purpose of Colorado Horse Rescue is to promote the prevention of equine abuse because we believe in humane treatment and survival as an alternative to slaughter or public auction for abandoned, neglected and unwanted horses. We shall provide shelter, food, daily care, medical

We shall obtain legal ownership of donated horses accepted into our guardianship, with the goal to place these horses into caring and suitable adoptive homes. Our number one focus is helping special needs Chihuahuas live a loving, safe, dignified and, of course, joyous life. If possible, we adopt-out our special-needs dogs to homes where they will be wanted, loved, and cherished for all of their days. If their special needs are too great, or a willing and loving home is not found for them, they live with us all their lives. Our dogs come from shelters and were all slated for euthanasia before reaching us. Their special needs range from physical issues, such as congenital deformity, limb damage, heart trouble, epilepsy, etc., to severe psychological/socialization issues. Each dog's therapy is different, as each dog's needs is different.

Our second focus is on elderly or hospice care small dogs. Hundreds of thousands of terminally ill and/or elderly Chihuahuas are dumped-off into shelters every year. At a shelter, old and sick dogs stand virtually no chance of being adopted. They are often terrified and in pain until they are euthanized by caring, but overworked, shelter staff. Sadly, our space is very limited so we can only take in a fraction of those in need. Our

dogs are loved and cared for until the very end, and we pay particular attention to a fear-free, pain-free, dignified death. Euthanasias, when needed, are done in our home, by our caring veterinarian, and the dog is held and loved the whole time. We believe a fear-free, comfortable death is as important as a wonderful life, and strive to offer it to all those dogs who come here in a terminal stage. Our dogs live in a home environment, cage-free, and are very, very loved.

The Horse Shelter's mission is to see that New Mexico's horses are as safe and well cared for as possible. Their approach is a multi-faceted one; while their main mission is to help owners care for their own horses, some horses live at the Shelter itself, where they have run-in stalls and large paddocks and turn-outs, clean, healthy surroundings, appropriate food, good water at all times, veterinary care, farrier care, exercise when appropriate, and the attention of a live-in caretaker (and many volunteers).

The Horse Shelter also conducts a humane education program, reaching out to schools, clubs, and groups of all kinds. The presenters are trained, and they convey the message that kind and responsible treatment of others - horses and all two- and four-legged creatures - is rewarding in many ways. For some horses the Shelter will be a life-long sanctuary; carefully screened new caregivers will adopt others, after rehabilitation, if necessary. The staff of The Horse Shelter investigates all reports of abuse and neglect, and makes every effort to improve a situation instead of removing a horse from his guardian, only taking a horse into the Shelter if such efforts fail.

Habitat for Horses is located on a 27-acre ranch in Galveston County, Texas. Midway between the booming economy of NASA at Clear Lake and the tourist town of Galveston, the local area is predominately rural, with a large

population of horses. Our ranch facility was donated to us by a former Galveston police officer. In addition to the ranch, we have a 3-stall ICU barn at a separate location, currently housing those horses unable to exist within the ranch herd. Volunteers built everything on the ranch, including paddocks, shelters, fencing and water lines. The materials were paid for by donations from our members. The exact location of the ranch is not publicized because of threats made against the horses and the staff by abusive owners who have had their horses removed from them. Visitors and volunteers must be cleared by the staff prior to visiting and are allowed on the ranch only by appointment. The watchful eyes of the Hitchcock Police Department maintain security. We are a 501(c)(3) nonprofit organization registered with the IRS and incorporated in the state of Texas.

The center was established by the Texas A&M College of Veterinary Medicine in 1993 at the suggestion of Dr. E. W. "Ned" Ellett, former head of the Small Animal Clinic at Texas A&M University. Dr. Ellett's dream became a reality with generous donations from the Luse Foundation and Mrs. Madlin Stevenson. Mrs. Stevenson said she chose to support the center because, "animals are especially important to the elderly; this center is dedicated to them and their pets." Mrs. Stevenson, a life-long animal lover, passed away in September of 2000. Her 4 cats, 7 dogs, pony, and llama came to reside at the center at that time. Another one of her cats is enrolled in our Extended Home Care Program. Our residents feel at home in the Center. It is designed in a relaxed fashion. The animals have freedom to roam and explore at will, while also having space for themselves during quiet times. Medical care includes regular physical examinations and laboratory tests as needed. Each pet is observed in order to develop a personal "wellness" program. When our pets need medical attention, their care is provided by the Texas A&M Veterinary Medical Teaching Hospital. Their knowledge of the latest advances in veterinary medicine, combined with the use of our specialized facilities, ensures the best possible care for our residents. Residents receive daily exercise with scheduled walks and activities conducted by student residents as well as regular bathing and grooming. Nutritional concerns are also monitored and special diets are developed for residents with special needs.

If you prefer that your cat(s) not become a general population family member, then we do offer the option of adding a cabin exclusively for your cat(s). This option is available on a very limited basis and we are willing to discuss down payment and reservation options with you. As stated, Furry Friends Haven is a no-kill hospice. However, when the quality of life for one of our family members deteriorates to the point where there is more pain than pleasure, we ask a veterinarian to provide the cat or dog with compassionate euthanasia.
